4. The Bank reserves the right to modify, not process and delay processing any instruction given by the applicants using the "HNB PAYFAST SYSTEM".
5. The terms & conditions governing Current Accounts, Savings Accounts and such other rules and regulations applicable to accounts would be binding on the applicant of "HNB PAYFAST" facility.
