

SUBORDINATED, REDEEMABLE DEBENTURES

The Board of Directors of Hatton National Bank PLC at its meeting held today, decided to issue Fifty Million (50,000,000) Basel III compliant -Tier 2, Listed, Rated, Unsecured, Subordinated, Redeemable Debentures with the option to issue further Twenty Million (20,000,000) Debentures, at an issue price of Rs. 100/- per Debenture.

The tenor of the Debentures shall be 5 years and 7 years and would be subject to market conditions and obtaining all necessary regulatory and shareholder approvals.
